C2 - wall

- Constructability: Wall option would have multiple conflicts with utility lines. Existing wall would have to be removed.
- Active Mode Connections: Would not impact existing formal pathway connections. Would not impact connections to pedestrian bridge at the Sunalta Elementary School. • Green Space: Would bisect existing green space potentially limiting functionality of the space and
- impact existing sledding hill.
- Safety: Wall option would block visibility of green space users to Crowchild Trail.

C2 - berm

- Constructability: Berm option would have multiple conflicts with utility lines. Existing wall would have to be removed. Would have the highest overall construction cost compared to the other options.
- Active Mode Connections: Would not impact existing formal pathway connections. Would not impact connections to pedestrian bridge at the Sunalta Elementary School. • Green Space: Would provide a more natural feel to the existing green space as compared to a wall. Would bisect green space potentially limiting functionality and impact existing sledding hill. • Safety: Berm option would block visibility of green space users to Crowchild Trail.

- **Constructability:** Wall option has few conflicts with utility lines. users. Would not bisect green space or impact existing sledding hill.
- Active Mode Connections: Would not impact existing formal pathway connections. • Green Space: Wall option would block Crowchild Trail traffic, improving experience for green space • Safety: Wall option would block visibility of green space users to Crowchild Trail.

Why this option is no longer being considered

• **Constructability:** Wall option has few conflicts with utility lines.

- Active Mode Connections: Would not impact existing formal pathway connections. Would not impact connections to pedestrian bridge at the Sunalta Elementary School.
- Green Space: Would block view of green space from adjacent properties on 22 Street S.W. and access to green space from 22 Street S.W. would be limited.
- Safety: Green space users would not be visible from adjacent properties.
- Community Input: We heard throughout the Crowchild Trail Study that a noise wall adjacent to 22 Street S.W. was not a desired location and that other locations should be explored.
