Blanket Rezoning - What Does it Mean for Ward 13?



R-CG Zoning

What are the specific rules in R-CG?


- Height: 11 metres
- Uses: single-detached, semi-detached, rowhouse, townhome, fourplex
- Density: 75 units per hectare
- Parking: 0.5 stalls/unit and 0.5 stalls/ suite minimum



R-G Zoning

What are the specific rules in R-G?

- Height: 12 metres
- Uses: permitted use suites, semi-detached dwellings, rowhouses and single detached homes
- Density: each dwelling unit requires a minimum parcel area of 150 m² (1 unit/0.015ha)
- Parking: generally 1 stall per unit, but is dependent on the type of housing

NOTICE OF MOTION

RE: Plebiscite on City Wide Blanket Re-Zoning

WHEREAS Council approved the Caigary Housing Strategy "Home is Here -- The City of Caigary's Housing Strategy 2024-2030".

AND WHEREAS One of the key actions in Housing Strategy is to propose citywide rezoning to a base district of R-CG and return to Council with the proposal by Q2 2024.

AND WHEREAS Actions related to rezoning and land-use or bylaw changes are required to follow the regular legislated process.

AND WHEREAS Public engagement on city wide rezoning began on January 15, 2024. This included a citywide mail out and a series of in person and online sessions for the public and industry which began on January 30, 2024.

AND WHEREAS A public hearing on the blanket R-CG rezoning is scheduled for April 22, 2024.

AND WHEREAS Many Calgarians have contacted their Councillors offices in opposition to blanket reconing, with concerns related to their property value, their neighborhood character, and other potential issues including, but not limited to increased crime, traffic, and parking.

AND WHEREAS Blanket rezoning impacts every low density residential property owner, every property taxpayer, and all Calgary residents as well as the character and nature of the communities in which they live.

AND WHEREAS The City of Calgary has previously held plebiscites on issues of public importance including The 2026 Winter Olympics bid and the re-installation of fluonde into Calgary's drinking water system.

THEREFORE BE IT RESOLVED that Council cancel the 2024 April 22 Public Hearing Meeting of Council.

AND FURTHER BE IT RESOLVED that Council direct City Administration to plan for and prepare a vote of the electors on city wide blanket rezoning to be in held in conjunction with the Municipal Election on October 20, 2025.

Plebiscite Motion – Why Did Councillor McLean Present the Notice of Motion?

- Proposal was to postpone the April 22nd Public Hearing and hold a plebiscite on blanket rezoning at the October 2025 Municipal election
- This was meant to encourage a more fulsome public debate and to ensure residents would be able to have their voices heard
- Motion defeated 8-6 at the Wednesday, March 13th, 2024 Special Meeting of Council


