Description of fund:

Seeds of Change is a one-time capacity-building fund to be allocated to organizations with a mandate and/or experience to build the capacity of their member organizations and/or groups by advancing the resources, capabilities, and knowledge.

Successful organizations will use The City of Calgary’s Anti-Racism resources as a tool to raise awareness about systemic racism, its impact on Indigenous, Black and diverse Racialized Calgarians, and how to address it within their respective lines of service using an intersectional lens.

Eligible one-time projects can be started as of August 1, 2025, and to be completed and funds spent by August 31, 2027.
