Submitting the Pre-Qualification Form and receiving a Project Application Form does not guarantee eligibility or financing through the Program; project financing is only reserved once a financing agreement is signed with the municipality.
- Upgrade installations cannot begin until you are pre-qualified, have completed an EnerGuide Home Evaluation, the Project Application Form is approved, and you have signed the required Program agreements.
