## **Verbatim Comments**

The comments below are as they were submitted by participants attending the events and at the online portal pages. No edits have been made but personal information or offensive language is removed with an indication that this has happened.

Route-specific comments are divided by route and into three categories for each route, answering the three engagement questions:

- 1. What do you like about the proposed route? (positive feedback)
- 2. What would you change or think could be improved about the proposed route? (negative feedback)
- 3. Is there anything else you think we should know? (general feedback)

General, non-route-specific comments and Evaluation comments follow the route-specific verbatims.

What do you like about the proposed route?

- I would have it go to 90th so I don't have to walk from 106 to 90 and back. I can't imagine having to do that in the winter.
- I would stop it at Douglasdale bus loop and extend it into Quarry Park. At Douglasdale, they then have the option of 302 to go north, in QP the SX or 92/96 to Anderson. Then the 24 can go away without dropping it to QP.

- It's a bad idea. A lot of people use that route from Anderson to 90th and beyond. Some people go from Woodbine
- Leave the same as the 409 or at least have it run to 90th ave.
- not sure if a 19:00 cut off time would be beneficial to employees that work nights
- Nothing
- Reduce zig-zagging in the industrial area. Perhaps another route can travel

- out of the Dufferin area and the 150 can travel further north?
- Shift time east of 24 street are just different than other parts of the city.
   Some work on the evening late night and early morning would help.
- This route will add a half hour walk to get to my work. This is not acceptable. Instead of providing better service it's getting worse. I really don't want to be walking a half hour in -30 weather let alone nice weather.

Is there anything else you think we should know?

- I've ridden the 24 through East Lake and literally no one gets on that bus in that area. Those that do get off at Douglasdale to get to their final destination, but changing as above you're not removing anything.
- The City can spend millions on the Olympics and is cutting back transit.
   From my perspective the transit system is much more important to serve the City as a whole.
